Human Care Program We provide holistic human care for each child in our program. More than just providing basic necessities such as food, shelter, medical care and education - we provide all sorts of extras. The children in our program grow up feeling a real sense of family, stability and love.



Housing Program - In 2018, we provided a safe home environment and loving family atmosphere for 74 children who would otherwise be living on the streets of Jinja or Kampala. The PFP Foundation has three homes for its children. Hope Home for boys, Peace Home for girls, and Love Home for toddlers. We also support children who are in our transition program and live in PFP provided housing in the local community. These children are over the age of 18 and are learning the life skills to eventually be fully on their own.

Medical Care Program - We provide holistic medical care for each child in our program. Each child receives a general medical checkup 6 times per year. When ill, children are treated promptly. We provide dental care and mental health counseling when needed. PFP has a nurse on staff, living at the youngest children's home. She is available for all children in the program at any time. We provide peer support sessions for children struggling with emotional burdens. Each child has a comprehensive immunization schedule that is followed until all immunizations have been obtained. Finally, we provide education on medical health conditions and access to family planning and birth control methods for graduates of our program, 18 and above.

Food Program - in 2017, we provided three healthy meals plus 2 snacks per day for 85 children.
